# **SUMMARY**

This report reflects the findings of a high-level assessment of the Sociometrics Platform for its conformance with the W3C Web Content Accessibility Guidelines version 2.1 (WCAG 2.1).

There are several WCAG 2.1 AA compliance issues with the Sociometrics platform and some of them are major issues that will significantly impact users with accessibility needs. For remediation it will be important to carefully review the WCAG 2.1 AA web standards. Below are the most critical issues to address to improve system compliance.

# Top Findings

- 1. **Color Contrast:** There are several different contrast violations across the site including static color contrast issues, as well as for links, and the different states of elements on the site. Please review the <u>WCAG 2.1 AA Standards for Color Contrast</u> on the web.
- 2. **Zooming and Scaling:** Zooming and Scaling, a major accessibility necessity for visually impaired users to navigate the site, needs to be enabled across the platform.
- 3. **HTML Language:** Several of the pages do not have a language defined for them. This can cause issues for screen readers and make it more difficult for non-sighted users to navigate the site.
- 4. **Keyboard Focus:** Keyboard focus across the site is inconsistent. Some elements have some indication of focus, but most of them do not. This makes it extremely difficult for someone that requires keyboard navigation to interact with the site.

#### **Best Practices**

- ♦ Ensure landmarks are unique.
- ♦ Document should have one main landmark.
- All page content should be contained by landmarks.
- ♦ Heading levels should only increase by 1.





### **Accessibility Findings**

This report was conducted against the Sociometrics Platform and covers a selection of pages and features that were to be tested as a representative sample of the database's conformance to the WCAG 2.1 AA standards.

The resource was reviewed using a combination of manual and automatic review tools and assistive technologies, including the WAVE Accessibility Assessment tool, Axe Accessibility Assessment tool, WCAG Color Contrast Checker, and NVDA screen reader. PDF content was tested against Section 508 requirements using Adobe Acrobat's accessibility tools and manual analysis. All problems identified by automatic tools were verified manually. This evaluation was performed using Firefox on Windows 11.


Below are the errors revealed during the accessibility evaluation of the Sociometric Platform. Each result shows a summary of accessibility issues and the reason it was flagged. Screenshots are included.





# 1. Initial Interface

**Test Case**: Test initial interface/landing page to ensure menus, sub-menus, search box, images, icons, etc. are accessible. URL: https://www-socio-com.utk.idm.oclc.org/



**SC 1.4.1:** Links must be distinguishable without relying on color.




